The author argues why preservation of the world's rural villages is important and why such often frustrating work is rewarding and worth the considerable effort. The book closes with unexpected lessons drawn from a lifetime beyond the end of the road. Humor, violence, friendship, and betrayal lace an account of unusual and creatively original research.
