They are aware that the classical structure of reflection on the law, present already in the Renaissance thought, has been replaced by another: the reflection on the universal purpose of the human species has been taken over by reflection on the multiplicity of objectives of the individual and the search for a guarantee of their realisation, sometimes taking into account the objectives of the state as a particular kind of being, which is to some extent independent of the existence (and objectives) of its constituent individuals.
