The second half of the book focuses on end-time events: the three angels' messages, the latter rain, the sealing, Armageddon, among others. It ends with the Second Coming and the millennium. Each chapter is filled with Bible texts, Ellen G. White quotes, and a list of Supportive Sources for further study. The book is a tremendous resource for Bible teachers, ministers, and church members.
