The practitioner systematically changes the lenses and asks the patient to compare clarity between different options (e.g., "Which is better, lens one or lens two?").

This subjective process, known as subjective refraction, is often complemented by objective measurements using an autorefractor or retinoscopy. The autorefractor projects light into the eye and measures its reflection to estimate refractive error automatically. Retinoscopy involves shining a light into the eye and observing the reflection off the retina, allowing the clinician to approximate the prescription before refining it subjectively.
