BROWN V. BOARD OF EDUCATION (1954)

ROE V. WADE (1973)

A DEEPLY CONTROVERSIAL AND WIDELY DISCUSSED CASE, ROE V. WADE RECOGNIZED A WOMAN'S CONSTITUTIONAL RIGHT TO PRIVACY REGARDING ABORTION DECISIONS. WORKSHEETS ADDRESSING THIS CASE HELP STUDENTS UNDERSTAND PRIVACY RIGHTS AND THE ONGOING DEBATES SURROUNDING REPRODUCTIVE FREEDOM.

MIRANDA V. ARIZONA (1966)

THIS CASE LED TO THE FAMOUS "MIRANDA RIGHTS," REQUIRING POLICE TO INFORM SUSPECTS OF THEIR RIGHTS DURING ARREST. LEARNING MATERIALS OFTEN HIGHLIGHT ITS SIGNIFICANCE IN PROTECTING INDIVIDUAL RIGHTS WITHIN THE CRIMINAL JUSTICE SYSTEM.

OTHER NOTEWORTHY CASES

- *DRED SCOTT V. SANDFORD* (1857) – A DEEPLY FLAWED RULING ON SLAVERY THAT FUELED TENSIONS LEADING TO THE CIVIL WAR
- *UNITED STATES V. NIXON* (1974) – AFFIRMED THE PRINCIPLE THAT THE PRESIDENT IS NOT ABOVE THE LAW
- *OBERGEFELL V. HODGES* (2015) – LEGALIZED SAME-SEX MARRIAGE NATIONWIDE

USE THE WORKSHEET AS A SPRINGBOARD FOR DISCUSSION OR DEBATE. FOR EXAMPLE, AFTER ANALYZING *BROWN V. BOARD OF EDUCATION*, ASK STUDENTS HOW SEGREGATION POLICIES MIGHT STILL AFFECT SOCIETY TODAY.

INTEGRATE MULTIMEDIA RESOURCES

SUPPLEMENT WORKSHEETS WITH VIDEOS, PODCASTS, OR INTERACTIVE TIMELINES. HEARING ORAL ARGUMENTS OR SEEING PERIOD NEWS FOOTAGE CAN BRING THESE CASES TO LIFE FAR BEYOND THE WRITTEN WORD.

APPLY REAL-WORLD CONNECTIONS

BALANCING DEPTH AND ACCESSIBILITY

STRIKING THE RIGHT BALANCE BETWEEN COMPREHENSIVENESS AND ACCESSIBILITY REMAINS A PERENNIAL CHALLENGE. WHILE DETAILED ANALYSIS IS CRUCIAL FOR ADVANCED LEARNERS, OVERLY DENSE CONTENT MAY OVERWHELM YOUNGER OR LESS EXPERIENCED STUDENTS.

CUSTOMIZABLE WORKSHEETS THAT ALLOW TEACHERS TO TAILOR CONTENT DIFFICULTY AND FOCUS AREAS REPRESENT AN EMERGING SOLUTION. THESE ADAPTABLE TOOLS CAN CATER TO VARIED LEARNING OBJECTIVES AND STUDENT CAPABILITIES WITHOUT SACRIFICING EDUCATIONAL RIGOR.
