Unfortunately, there are good handgun training classes, and there are others that are not adequate. These kinds of classes cut corners on essential information - a dangerous practice! This isn't a dance class, where the worst thing that can happen is that you step on someone's toes; it's an educational beginning in the use of a lethal weapon. I'm an NRA Certified Firearms Instructor. I've been shooting for much of my life. My first formal handgun class, about 20 years ago, was excellent. The instructor was an expert in what he was teaching. He hammered the things we needed and drilled us on the range. That first class was tremendously informative. Several years ago, after taking additional classes and getting my NRA instructor certification, I talked with an independent instructor at a gun show, and I began to wonder just how truthful he was being about his classes. So, I took his class, and found out there was a lot of space between his promises and his product! I became curious about the overall quality of other handgun classes. Were all gun classes as good as the ones I'd taken at first, or were they more like that of the guy at the gun show? Had I assumed a general level of quality that wasn't really there? It turned out, the answer was yes. I went underground - became sort of a secret shopper, and took a number of handgun classes at my own expense. In the last three years, I've concentrated on classes that claim they will teach a beginning shooter all of the necessary fundamentals of shooting and qualify them to apply for the concealed handgun permit. These classes can issue a certificate allowing the new shooter to apply for a concealed handgun permit. With that permit, the shooter can legally carry a concealed handgun, subject to certain location restrictions. (A class completion certificate signed by an NRA Certified Instructor, and fees for administrative handling and background checks, are all that are required to apply for the permit. In the State of Colorado, where I live, the student is not required to actually fire a gun or prove competency in order to obtain a Concealed Handgun Permit. I believe this policy is too lax.) Now, you would hope all classes would all teach at least the minimum of gun knowledge needed... that they would drill a certain amount of live-fire practice, and turn out new or re-educated shooters who can carry a concealed handgun and use it safely, competently, legally and ethically if they are forced to defend themselves or others. That's what I expected to

discover. But, that isn't what I discovered. I found out that many classes simply do not even teach new shooters the basics they need to know to be safe with their handguns, operate them well, and fire accurately! Your goal is to find a gun class that will teach you thoroughly and well. After reading this ebook, you will know how to find a good class. You'll know: 1. What should a good basic gun class teach? (Classes are not all the same!) 2. How do you figure out before you sign up whether or not a given class will teach well? (Their ads will not help with this!) 3. How to know if the instructor is a real teacher, who wants you to learn about your gun and is capable of teaching you? (I'll tell you exactly how to know.)
