MIND-BODY PRACTICES

MEDITATION, YOGA, TAI CHI, AND GUIDED IMAGERY ARE EXAMPLES THAT ADDRESS MENTAL AND EMOTIONAL HEALTH, OFTEN

SAFETY CONSIDERATIONS AND INTEGRATING ALTERNATIVE MEDICINE INTO CARE

ASSESSING RISKS AND BENEFITS
