The only way to enter into the coming kingdom is to grow into the kingdom. Second Peter 1:5-11 reveals that our growth in life to maturity becomes an entrance into the kingdom richly supplied to us. The law of the Spirit of life is the subject of Romans 8. God's life is the highest life, and the law of this life is the highest law. The law of the Spirit of life is not a thing but a person-the processed and consummated Triune God embodied in Christ and realized as a living law in our spirit. This law of life is the spontaneous power, the natural characteristic, and the innate, automatic function of the divine life. While we remain in touch with the Lord, staying in contact with Him, the law of the Spirit of life works automatically, spontaneously, and effortlessly to dispense God as life into our being and to overcome the law of sin and of death (vv. 10, 6, 11). We activate the law of the Spirit of life by remaining in touch with the Lord. We need to cooperate with the indwelling, installed, automatic, and inner-operating God by prayer and by having a spirit of dependence, thus maintaining our fellowship with the Lord of life and the Lord of work. Romans 8 reveals that the processed Triune God as the law of the Spirit of life gives the divine life to the believers for their living. There are four laws in Romans 7 and 8. One law is outside of us, and the other three correspond to the three lives that are within us as regenerated persons. Outside of us is the law of God, the law of moral commandments, which is a portrait of God. Within us is the law of sin and of death in our flesh, the law of good in our soul, and the law of the Spirit of life in our spirit. The only way we can match and become the living portrait of God is by living according to the law of the Spirit of life in our spirit. God's desire and goal are that we live by the divine life and minister life to others for the building up of the church. The all-inclusive, indwelling Spirit is constantly transmitting this life into each one of us to build up the church, edify the saints, and minister the riches of Christ to everyone who contacts us. In Romans 8 we also see that the desire of God's heart is to have many sons for His corporate expression (v. 29). The Father sent His Son--who was born under the law and born through a woman--to redeem us out from under the law. Having redeemed us, He sent forth the Spirit of His Son into our hearts, crying, 'Abba, Father!' (Gal. 4:6). Now our spirit has become a spirit of sonship. As the divine life grows within us and transforms us, it spontaneously shapes us into the form, the image, of the firstborn Son of God. We are to be conformed to the image of God's firstborn Son, Christ as the first God-man, that we may be a group of God-men who are exactly like Him. Paul's Epistle to the Romans reveals God's complete salvation in two aspects. God's judicial redemption is the procedure of God's complete salvation for the believers to participate in God's organic salvation as the purpose of the complete salvation of God. Redemption entails the forgiveness of all our sins, reconciliation, positional sanctification, and justification. God's organic salvation is the organic aspect of God's complete salvation through the life of God (Rom. 1:17b; Acts 11:18; Rom. 5:10b, 17b, 18b, 21b) as the purpose of God's salvation, accomplishing all that God wants to achieve in the believers in His economy through His divine life (Gen. 2:9; Rev. 22:14). Organic salvation entails regeneration with God's life, sanctification with God's holy nature, renewing with God's element, transformation with God's being, conformation into God's image, and glorification, which is our full sonship. Glorification sonizes our whole being, from spirit to soul to

body. All the items of God's organic salvation are carried out by Christ as the life-giving Spirit in His heavenly ministry organically and subjectively. Being saved in His life is actually the process of resurrection, with the resurrection life of Christ as the element, increasingly taking place in our inner being so that we are sanctified, which is to be saturated with God's holy nature. It is in resurrection that we are renewed, we walk in newness of life, and we serve in newness of spirit (Rom. 6:4; 7:6). The experience of God's organic salvation equals reigning in Christ's life. The issue of our reigning in life, living under the ruling of the divine life, is the real and practical Body life expressed in the church life (12:1-4, 9-12, 15, 18). the law of spirit of life: The Grace of Christ, Third Edition Eric Roessing, 2023-09-28 The purpose of this book is to communicate as clearly as possible Paul's gospel of God in its depth, from what I have learned over five decades of studying Paul's letters and theology. But, regardless of how much I have gained from teachers past and present, the bottom line is that the things freely given us by God in Paul's gospel can only be known by the Spirit of God, through comparing Paul's Spirit-taught words with Spirit-taught words (1 Cor 2:12-13). Luther's grasp of how justification in Christ--and thus faith in Christ--is central, is verified by what Paul says in Rom 1:16-17; that in the gospel, God's saving righteousness is revealed, from Christ's faith to our faith. The message of this book can be summed up as follows: The life of the person in Christ is to be one of trust in Christ for righteousness before God, and, through that faith, obedience to Christ as Lord. This life is possible because Christ believers have died with Christ to the lordship of the Sin and the law, and are alive to God in Christ Jesus--owned by him as Lord, being one spirit with him.

the law of spirit of life: The Collected Works of Witness Lee, 1953, volume 1 Witness Lee, Brother Witness Lee traveled to Manila, Philippines, on December 10, 1952, and stayed there until June 30, 1953. During this time he released messages that compose the first six chapters of The Bridge and Channel of God, which appears in volume 1 of this set. A collection of his personal notes written in Ianuary is included in volume 1 of this set. On June 1 through 14 he conducted a training on service in the mornings with brothers who attended from the Philippines as well as from other Southeast Asian countries. The main subject of these meetings was on the conditions for God to use man and on the knowledge needed for those who serve the Lord. In the evenings he spoke to the whole church on God's need for man and the life of service. After this, he conducted meetings in Baguio, Philippines, for three days beginning on June 15, with two meetings every day. The subject of these meetings was on the life and living of the Lord's serving ones and the revelation and way for service. These messages were originally published in The Ministry of the Word, Issue Nos. 27 and 28, and are included in volume 1 of this set under the title The Ministry of the Word, Miscellaneous Messages, 1953. After returning from Manila on June 30, Brother Lee remained in Taiwan for the rest of the year. Beginning on August 9 he conducted an eleven-day conference on life and the church with over two thousand in attendance. These messages are included in volume 1 of this set in the section entitled Knowing Life and the Church. The most significant event of this year was a sixteen-week training that began in September and ended in the middle of December. This was the most crucial training during the first few years of the work in Taiwan. All the sections in the remainder of the 1953 set are from messages released during this training. These include The Knowledge of Life and The Experience of Life, both of which have become crucial books in the Lord's recovery since that time. Some of the messages in these sections were given in 1954. The Collected Works of Witness Lee, 1953, volume 1, contains messages that Brother Witness Lee gave in 1953. This volume also includes notes, articles for publication, and an outline written in the same year. Additionally, prayers offered by Brother Lee in meetings from 1953 through 1957 are included in this volume. Historical information concerning Brother Lee's travels and the content of his ministry in 1953 can be found in the general preface that appears at the beginning of this volume. The contents of this volume are divided into nine sections, as follows: 1. Eight messages given in Taipei, Taiwan, and Manila, Philippines, in 1953. These messages were previously published in a book

entitled The Bridge and Channel of God and are included in this volume under the same title. 2. A collection of personal notes written in January 1953. These are included in this volume under the title Witness Lee's Personal Notes. 3. Two messages given in Manila, Philippines, on June 12 and 13, 1953. These messages are included in this volume under the title Concerning the Lord's Work and God's Move. 4. Twenty-three messages given in Taipei, Taiwan, in August 1953. These messages were previously published in a book entitled Knowing Life and the Church and are included in this volume under the same title. 5. Nine articles and reports that appeared in various issues of The Ministry of the Word in 1953. They are included in this volume under the title The Ministry of the Word, Miscellaneous Messages, 1953. 6. Four messages given in Taipei, Taiwan, on August 18 and 20, 1953. These messages are included in this volume under the title Fellowship in Preparation for the Service Training in Taipei. 7. A detailed outline written in 1953 showing the subjects that were covered in the training on service in Taipei, Taiwan. This outline is included in this volume under the title Outline of the Service Training in Taipei. 8. Five messages given during an intensified sixteen-week training on service in Taipei, Taiwan, on September 1 through December 18, 1953. These messages are included in this volume under the title The Human Conduct and the Ministry of the Word of the Lord's Serving Ones. Most of the content of the service training and the fellowship that followed the training is published in volume 2 of this set in the section entitled Messages and Fellowship Given during the Service Training in Taipei. 9. A collection of nineteen prayers offered by Brother Lee in meetings held in Taipei, Taiwan, and Hong Kong from 1953 through 1957. They are included in this volume under the title A Collection of Prayers.

the law of spirit of life: The Collected Works of Witness Lee, 1988, volume 1 Witness Lee, 2021-05-28 The Collected Works of Witness Lee, 1988, volume 1, contains messages given by Brother Witness Lee from January 3 through December 18, 1988. In 1988 Brother Lee spoke fifty-six messages that were published in the Life-study of Leviticus. These Life-study messages are not included in The Collected Works of Witness Lee. Brother Lee remained in Irving, Texas, during the first part of January 1988. He returned to Anaheim, California, in the middle of January and again traveled to Irving in February, where he remained until the first part of March. From then until the third week in March he visited Seattle, Washington; Vancouver, Canada; and Berkeley and San Jose, California. In the last week of March Brother Lee visited Spokane, Washington, and San Francisco, California, before he returned to Anaheim. In the first few days of April he visited San Jose for two days, and in the second week of April he flew to Taipei, Taiwan, and remained there until early June. He returned to Anaheim and remained there through the third week of July. In the remaining days of July he visited a number of cities in the San Francisco Bay Area, including Berkeley, Hayward, San Jose, Los Altos, and San Francisco, California. In early August he visited Spokane, and at the end of August he visited Seattle. In the last few days of August he visited Alhambra, California, and in September he traveled to Cleveland, Ohio, and Atlanta, Georgia. In early October Brother Lee visited Taipei for one month before traveling to Seoul, South Korea, and then back to Taipei, where he remained until the middle of November. He then returned to Anaheim and remained there until the middle of December. During his time in Anaheim he also ministered in Pasadena, San Gabriel, and Monterey Park, California. In mid-December he traveled to Irving and remained there through the early days of January 1989. The contents of this volume are divided into fourteen sections, as follows: 1. A message given in Irving, Texas, on January 3, 1988. This message is included in this volume under the title The New Way for the Lord's Recovery. 2. Six messages given in Chinese in Anaheim, California, on January 15 through 31.
