THIS DOMAIN REQUIRES BOTH TECHNICAL KNOWLEDGE AND AN APPRECIATION FOR CONTROL ENVIRONMENTS.

INFORMATION SYSTEMS OPERATIONS AND BUSINESS RESILIENCE

QUESTIONS HERE FOCUS ON OPERATIONAL CONTROLS, DISASTER RECOVERY, AND BUSINESS CONTINUITY PLANNING. YOU MIGHT BE ASKED:

- HOW DO YOU ASSESS THE ADEQUACY OF BACKUP PROCEDURES?
- WHAT ARE THE CRITICAL COMPONENTS OF A BUSINESS CONTINUITY PLAN?

PRACTICAL EXPERIENCE OR CASE STUDIES RELATED TO OPERATIONAL RISK MANAGEMENT CAN BE BENEFICIAL.

PROTECTION OF INFORMATION ASSETS

THIS DOMAIN TARGETS CYBERSECURITY, PRIVACY ISSUES, AND PHYSICAL SECURITY CONTROLS. EXAMPLE QUESTIONS INCLUDE:
