WHY ASBESTOS EXPOSURE LEADS TO LEGAL CLAIMS

GIVEN THE WELL-DOCUMENTED HEALTH RISKS OF ASBESTOS, MANY COMPANIES FACED LAWSUITS FOR FAILING TO WARN WORKERS OR THE PUBLIC ABOUT EXPOSURE DANGERS. IN WINSTON SALEM, WHERE INDUSTRIAL AND MANUFACTURING SECTORS HAVE HISTORICALLY PLAYED A SIGNIFICANT ROLE, MESOTHELIOMA CASES OFTEN REVOLVE AROUND:

- OCCUPATIONAL EXPOSURE AT FACTORIES, SHIPYARDS, OR CONSTRUCTION SITES

IF YOU ARE DIAGNOSED WITH MESOTHELIOMA AND ARE STILL ALIVE, YOU MAY FILE A PERSONAL INJURY LAWSUIT AGAINST COMPANIES RESPONSIBLE FOR YOUR ASBESTOS EXPOSURE. THESE LAWSUITS SEEK COMPENSATION FOR DAMAGES SUCH AS:

- MEDICAL EXPENSES FOR TREATMENTS LIKE CHEMOTHERAPY AND SURGERY
- LOST INCOME DUE TO INABILITY TO WORK
- EMOTIONAL DISTRESS AND PAIN AND SUFFERING

WRONGFUL DEATH CLAIMS

IF A LOVED ONE HAS PASSED AWAY DUE TO MESOTHELIOMA, FAMILY MEMBERS MAY BE ELIGIBLE TO FILE A WRONGFUL DEATH CLAIM. THIS TYPE OF LAWSUIT AIMS TO COMPENSATE THE FAMILY FOR LOSSES SUCH AS:

- FUNERAL AND BURIAL COSTS

ASBESTOS TRUST FUND CLAIMS

STATUTE OF LIMITATIONS AND DISCOVERY RULE
