2. BENEFICENCE

BENEFICENCE IS THE COMMITMENT TO ACT IN THE BEST INTEREST OF THE PATIENT. HEALTHCARE PROFESSIONALS ARE ETHICALLY OBLIGATED TO PROMOTE GOOD, PREVENT HARM, AND CONTRIBUTE POSITIVELY TO PATIENTS' HEALTH AND WELL-BEING. THIS PRINCIPLE ENCOURAGES PROACTIVE CARE AND COMPASSIONATE TREATMENT.

THE PRINCIPLE OF BENEFICENCE OFTEN REQUIRES BALANCING BENEFITS AGAINST RISKS, ENSURING THAT INTERVENTIONS PROVIDE MORE GOOD THAN HARM. IT ALSO MOTIVATES HEALTHCARE PROVIDERS TO STAY UPDATED WITH MEDICAL ADVANCEMENTS AND TO ADVOCATE FOR PATIENTS' WELFARE.

3. NONMALEFICENCE

CLOSELY RELATED TO BENEFICENCE, NONMALEFICENCE MEANS "DO NO HARM." IT COMMANDS HEALTHCARE PROFESSIONALS TO AVOID CAUSING INJURY OR SUFFERING TO PATIENTS. THIS PRINCIPLE ACTS AS A SAFEGUARD AGAINST NEGLIGENT OR HARMFUL PRACTICES.

WHILE SOME MEDICAL TREATMENTS CARRY INHERENT RISKS, NONMALEFICENCE URGES CAUTION, CAREFUL EVALUATION, AND THE

4. JUSTICE
