CROSS-REFERENCE WITH THE CONSTITUTION TEXT

WHEN ANSWERS REFERENCE SPECIFIC ARTICLES OR AMENDMENTS, TAKE THE TIME TO LOOK THEM UP IN THE ACTUAL CONSTITUTION. THIS PRACTICE NOT ONLY IMPROVES COMPREHENSION BUT ALSO BUILDS FAMILIARITY WITH THE DOCUMENT ITSELF.

DISCUSS WITH PEERS OR EDUCATORS

IF POSSIBLE, DISCUSS WORKSHEET QUESTIONS AND ANSWERS WITH CLASSMATES OR TEACHERS. GROUP DISCUSSIONS CAN UNCOVER DIFFERENT INTERPRETATIONS AND DEEPEN UNDERSTANDING.
