MOREOVER, HIS EMPHASIS ON EARLY IDENTIFICATION AND LONGITUDINAL MONITORING ENCOURAGES PREVENTIVE MEASURES AND TIMELY ADJUSTMENTS IN TREATMENT, POTENTIALLY IMPROVING LONG-TERM OUTCOMES.

CHALLENGES AND FUTURE DIRECTIONS
