THE 1850 CALIFORNIA CONSTITUTION WAS UNIQUE BECAUSE IT WAS DRAFTED IN A RELATIVELY SHORT PERIOD AND HAD TO ADDRESS CONTENTIOUS ISSUES SUCH AS SLAVERY, NATIVE AMERICAN RIGHTS, AND LAND CLAIMS. THIS CREATED A RICH COLLECTION OF DBQ DOCUMENTS THAT REFLECT DIVERSE VIEWPOINTS AND POLITICAL STRATEGIES.
