An animal can always be found which will represent the 'type' of its species. In all the great zoological collections there exist these 'species-types,' to which individuals may be compared in order to decide if they belong to the supposed species. We have then in zoology a real substratum for the determination of species, those primordial units which are grouped afterwards in genera, families, orders, etc.
